Specifically IOL course accreditation is not designed to cover:


- Courses for people who are participating in an outdoor learning programme (See the IOL supported National Outdoor Learning Award)
- Courses that are not aligned with or do not support the charitable aims and vision of the Institute for Outdoor Learning

# Pathway to Course Accreditation



#### Consider

1. Read through the guidance and decide if IOL accreditation is appropriate for your course.

### If you require further support just ask.

IOL consultancy can be provided if you need help in course design, delivery, assessment or application to outdoor learning.

#### Prepare

- 2. Download the application form and guidance notes from the IOL website.
- 3. Assemble all the evidence required and complete your application form.

#### Submit

4. Submit your full application and pay the required fee.

#### Assessment

5. Your application will be checked for completeness and considered by an IOL Accreditation Board.

The desk-based assessment covers all the criteria in detail.

6. For successful applications, receive your IOL Accredited Course Badge.

If your application is deferred, gather more evidence and re-apply.

#### Renew

7. Renew accreditation annually.



# **Quality of Training Criteria**

IOL Accreditation of CPD or training courses designed for instructors, teachers and leaders of Outdoor Learning requires evidence of meeting all the IOL quality of training criteria in the application form. A summary is given below.

Operates ethically with the appropriate policies and procedures in place	Confirmation of holding health & safety, equality & diversity, data protection, environmental impact, complaints, risk-benefit assessments and other relevant policies. Two recent client testimonials.
Endorsements	Existing accreditations, approvals or certifications
Motivation and drive	Description of the reasons for seeking course accreditation and the tangible benefits expected.

# **Support for Outdoor Learning**

Supports the outdoor learning sector	Membership of the Institute for Outdoor Learning prior to application.

# Frequently Asked Questions

### What types of courses do you accredit?

- Training Courses designed for ASPIRANT or NEW outdoor learning instructors, teachers or leaders
- CPD courses designed for EXISTING instructors, teachers or leaders to broaden or further develop their competence
- Educational courses a FE, HE, degree or masters course or similar) that is typically over 12 months or longer

### Which IOL Accredited Course Badge can I use?

We have a range of IOL Accredited Course Badges for you to use on certificates, promotional material and web listings when your course is accredited. You can choose to use whichever badge is most appropriate to your accredited course.

### Can I accredit a course made up of several modules?

Yes. It is important to be clear on certificates, promotional material and web listings that IOL course accreditation covers the whole course. If the modules are stand-alone and independent courses then each will require its own course accreditation.

### If IOL accredits a course does that mean IOL endorses the content?

By accrediting a course IOL is accrediting the process by which providers deliver the learning outcomes they have set out. IOL course accreditation confirms that the chosen <u>course content and training process is relevant</u> to practitioners of outdoor learning.

### Does IOL accredit individuals?

Yes, the IOL awards of RPIOL, APIOL and LPIOL.

### Does IOL accredit courses for people who are participating in outdoor learning?

No, we encourage providers to use the FREE to access IOL supported National Outdoor Learning Award.

### Do any courses have special requirements for accreditation?

Yes.

 Accreditation site visits are required for NEW applications to deliver IOL Bushcraft Competency Certificate training. They will be carried out by an



approved member of the IOL Bushcraft Professional Practice Group (additional charge).

2. Accreditation of **Outdoor First Aid courses** requires each course trainer to have passed the IOL Outdoor First Aid Questionnaire (additional charge) and the course content to meet or exceed the IOL Statement of Good Practice on Outdoor First Aid.

### Are discounts available for multiple courses?

Yes. Discounts are available for organisations that apply for accreditation of three or more courses in the same subject area at one time. Contact the IOL central office <a href="https://outgo.com">louise@outgo.com</a> louise@outgo.com</a>

### Does my course have to conform to external standards?

IOL accredited courses must meet all relevant legal or good practice guidelines that have been described and accepted within the field. IOL course accreditation can be independent of, or in addition to, any other form of course accreditation, approval or endorsement.

### Does the course have to include assessment?

The assessment methods for a course are a matter for the course provider to define. In learning terms, every course should have an aim, learning outcomes and an assessment process that identifies when the delegates have achieved the desired learning outcomes. Both formative assessment and summative assessment are usually expected.

### How much paperwork is there to complete?

The process is designed to check information that most course providers committed to high delivering quality learning experiences will have already considered.

Wherever possible we strongly encourage applying organisations to use evidence of accreditation with other bodies in their application. The aim is not to introduce unnecessary paperwork but to ensure an external, professionally based, quality assurance process.

### How are applications assessed?

Each application will first be checked for completeness and detail. Any missing information and the application will be returned to resubmit with the full information.

Once we have received a completed application it will be reviewed by at least two members from the following list:

- IOL Operations Manager
- IOL Regional Professional Development Co-ordinator



• IOL Professional Standards Manager

In addition, further specialist guidance will be sought where necessary to assess all areas of the application and particularly the sections relating to relevance to practitioners of outdoor learning and course design and assessment.

Guidance can come from one or more of:

- **Chair of relevant IOL Professional Practice Group or equivalent expert** to provide specialist advice or knowledge.
- **Employer or employers** who can comment on the suitability of the syllabus and need for the course from their perspective.
- **Practitioner(s)** as representatives of prospective delegates to the course to comment on the need, syllabus and teaching approach.
- **Partner organisations** that are supporting IOL Course Accreditation in a particular area (e.g. AHOEC for centre management/leadership courses).
- **IOL Chief Executive or Trustee** to ensure the charitable aims and objectives of IOL are upheld by accrediting a course in a particular area or field.

Each area of course accreditation is different and IOL will draw together an accreditation board that brings the appropriate specialisms to assess each application fairly.

### Is there a visit to my site?

IOL course accreditation is designed as a desk-based process. We only make a site visit where necessary to satisfactorily confirm the providers policies and procedures in action.

Accreditation site visits are required for NEW applications to deliver IOL Bushcraft Competency Certificate Training.

### What is the IOL quality assurance process?

IOL undertake monitoring of Accredited Courses each year. This will include looking at delegate questionnaires, annual reports and course material reviews.

Providers can expect that within the first couple of years of course accreditation IOL will monitor that what they said they would do regarding delivery of the course is actually taking place. This may include an open discussion to find out how well the course is working for the provider and how well it is meeting the needs of instructors, teachers and leaders who attend it.

### What is the renewal process?

The annual renewal process is to complete and submit your renewal form. You will be required to provide IOL with information that includes:



- How many Accredited Courses you have delivered in the past 12 months
- How many delegates attended each course
- Summary of course evaluations

Your accreditation will be renewed as long as it meets all the current criteria. In line with an IOL commitment to reflective practice it is expected that minor updates will occur each time a course is run, these will not usually require re-accreditation.

If there significant changes in your application at renewal you will be charged an amendment fee or, for larger changes, the full course accreditation fee.

### Can course accreditation be withdrawn?

IOL retains the right to withdraw accreditation at any time, including the reasons:

- Failure to comply with the current accreditation criteria
- Failure to comply with the policies and processes submitted at accreditation
- Significant changes to the course structure (learning outcomes, scheme of work)
- Significant changes to the facilitation team (selection & training process, trainers)
- Misuse of any branding, wording or logos of the Institute for Outdoor Learning

### Complaints

If you have any questions or queries about the process or your specific application please contact the IOL central office in the first instance. We will do our best to ensure that IOL Course Accreditation is right for you at this time and support you to complete your application in order to meet the criteria.

If you feel your application has been unfairly assessed, please contact the Professional Standards Manager who will look into the matter. Should this cause a conflict of interests then the IOL Chief Executive will look into your concerns and respond.
